Benton County Master Gardener Association Board Meeting –August 9, 2021

Gardening Moment: Jana has been having a deer incursion despite fencing. The suspect is a young deer who could get through gaps in the fence.

Minutes: The minutes were unanimously approved as amended.

Vice President: Alan Taylor

- Summer tour to Country Line Farms on Tuesday, Aug. 17. Carpooling is encouraged.
- September Picnic: Stay tuned for more details as pandemic restrictions are in flux.
- October Meeting: It was hoped to have a committee fair but some technology issues need to be resolved.
- November: It is Benton County's turn to host the Awards/Graduation ceremony. It is still unclear whether it will be possible to hold this event in its traditional format. Other options are being considered.

Treasurer: Marge Alig & Lynn Trimpe

- Lynn reviewed the checkbook for July. Ending balance \$73,854.74
- Marge reviewed the Statement of Financial Activity. Revenue is \$22,409.55, primarily from plant sales. Total expenditures are \$8,006.00.
- Marge reviewed the Statement of Financial Position. The total assets of the association are \$186,468.97.

President: Deb Kern

- Nomination Committee: Jana Tindall
 - President Elect Jana Tindall has appointed Christina Clark and Judith Kenner to the nomination committee to make recommendations on a slate of board nominations for 2022.
 - Jana requested that current board members let her know about their intentions for next year.

 Elizabeth will provide input, especially for possible newer members who may be good candidates.

• Greenhouse Clean up

- Next clean up party is on Saturday, Aug. 14. Need to keep on top of the weed so the job doesn't become overwhelming.
- Need to design an irrigation system for outdoor plant storage areas.

Membership: Deborah Hobbs

 Deborah informed the board that Judith Kenner has arranged for a Master Gardener outdoor get-together for those MGs who lived in her area of town. Deborah suggested that other MGs could replicate this in their own neighborhoods as a way of staying connected to one another.

OMGA Representative

- OMGA Mini College Report: Rich Taylor sent the Mini College report to all board members via email as he was unable to attend the board meeting.
- OMGA would like to know if people would like to have Mini College 2022 be an inperson, virtual, or a hybrid of the two.
- It was suggested that OMGA could monetize the recorded programs for a fee, therefore making them available to all MGs for continuing education. Rich will be asked to pass this along to the OMGA board.

Extension: Elizabeth Records

- Program update on facemasks: Facemasks are now required at all indoor activities if you are wearing your MG badge. They are not required at outdoor events.
- 2nd Year Trainees: There are 8 trainees remaining from the 2020 training group. They need help to complete desk hours. Elizabeth will add more time slots to the desk sign up and update the sign-up page to 2 shifts per day.
- At present, it is planned to have a 2022 training class. A program from Marion County
 that has an emphasis on outdoor activities is being assessed. Elizabeth asked the board
 to look this over and give input. The training would be a combination of Zoom classes
 and garden labs. The same number of trainees as in the past would be admitted to
 training.
- The Master Gardener storage area at the Extension office is full. Elizabeth would like chairs or a representative from committees that use that unit to join her for a clean-out session.

Greenhouse Committee: Nancy Tovar

 A new site was viewed by Nancy Tovar, Debbie Lauer, and Paula Lupcho in July. It is already fenced, has a well, and the site prep (leveling and graveling) would be done by the owner. • There was extensive discussion on the greenhouse project in general. A joint meeting of the Greenhouse Committee and Plant Sale Committee to revisit and review the goals, financial possibilities and constraints, and other considerations of this project.

Insights into Gardening: Lynn Trimpe

- A contract with La Sells Stewart Center has been signed for the 2022 IIG conference.
 This was necessary to insure the desired date (2nd Saturday in February).
- The cancelation policy is still in the contract. However, Mary Mellard (co-chair of IIG)
 has an informal agreement with the manager of LaSells that the cancellation policy
 would be overlooked if the event needed to be cancelled due to COVID.

Good of the Association

- Alan asked those at the meeting for feedback on the hybrid meeting format. There
 were some technical issues. Alan will work on resolving them in order to have a hybrid
 format for the October membership meeting.
- The was consensus that BOD night meetings will be held on Zoom.
